

LINCOLN FINANCIAL FIELD PHOTO SESSIONS

Thank you for your interest in having your wedding or family photos taken at Lincoln Financial Field. We hope to provide you with both a memorable backdrop and experience.

Please note the following requirements for your photo shoot:

1. Photo Session Requests will not be accepted more than ninety (90) days prior to requested date and are available **Monday through Friday with a start time of no later than 4pm**. Weekend Dates or after business hours are subject to approval and an additional fee.
2. Requests for photo sessions at Lincoln Financial Field must be submitted with a **\$500 payment**, plus a **\$50 donation** to Eagles Charitable Foundation ("ECF")*.
3. Reservations will be scheduled by Eagles Stadium Operator ("ESO"), at the discretion of ESO, by a first come-first serve method. You will receive a confirmation of your request by email with a copy of the photo session requirements.
4. This package is intended for **still photography only**. Requests for video production must be submitted separately and via email. Drone usage must be submitted and approved via email.
5. Please provide your own photographer. Photographers will need to work within the stadium lighting conditions that exist at the time of your photo shoot.
6. The Playing Field is not always painted or setup as a football field. There may also be maintenance, setup crews, practices, etc. that weren't previously scheduled that may fall on the date you request and could pop up the day before or even the day of your shoot. We will try our best to communicate with you the field conditions, but we may ask you to reschedule. **There is no guarantee of stadium or field condition during your requested date. There is also no guarantee that your group will be permitted on or around the Playing Field.**
7. You will have **one (1) hour** for your shoot. This includes set-up time, time to take photos and any time needed to move to different shoot locations within the stadium.
8. The size of your group is limited to the **ten (10) total participants**. This includes the photographer and his/her assistants. The group will be accompanied by a stadium staff member and everyone must remain with the group at all times. The charge for 11-20 people is \$750, and for 21-30 people is \$1,000. Groups shall not exceed thirty (30) total participants. Final Group Count & Names must be disclosed no later than two (2) weeks prior to the shoot date.
9. Photos are permitted on the field warning track, club lounges, bowl seats, and the Eagles Nest (a circular balcony that overlooks the field on the Upper Concourse level). Access to the areas is **NOT EXCLUSIVE**.
10. All props such as helmets, footballs, jerseys, etc. are allowed, but must be provided by the participants.
11. Rental of the Video Board is available for an additional \$250.00. A custom message and/or images can be placed on the video board for up to 1 hour. There may be an additional technician charge depending on request.
12. Alcoholic beverages may not be brought into the stadium. The Philadelphia Eagles encourage responsible behavior and reserve the right to cancel a photo session if the participants or guests do not follow these requirements or the instructions of stadium personnel. Intoxicated members of the group will not be permitted on property.
13. The Philadelphia Eagles reserve the right to bar any photo that in the sole opinion of the Philadelphia Eagles is not in good taste or depicts Lincoln Financial Field or the Eagles in any inappropriate manner.
14. All photos must be for personal use only. No images of Lincoln Financial Field or any portion thereof and no marks of the Philadelphia Eagles may be published or reproduced other than for personal use without the express prior written permission of the Philadelphia Eagles.
15. If the need to cancel or modify your request; please notify your ESO contact immediately.
16. **You acknowledge that Philadelphia Eagles shall have the right to change the date and/or time of the photo session for any reason, including the day of the scheduled shoot.**
17. All Payments are final and no refunds will be issued.
